Lyne Morissette is a research scientist co-holder of the UNESCO Chair in Integrated Analysis of Marine Systems at Institut des sciences de la mer de Rimouski (UQAR-ISMER), Canada. She earned her PhD in zoology specialized in marine ecology at the Fisheries Centre of the University of British Columbia in 2007. Before that, she did her M.Sc. in wildlife management at UQAR (2001) in collaboration with the Department of Fisheries and Oceans of Canada, where she worked for several years as an ecosystem modeller. She has been working on a variety of ecosystems in the North Atlantic, but also in the Arctic, the Caribbean, and the west coast of Africa. She's interested in marine mammals - fisheries interactions, the dynamics of exploited ecosystems, global impacts of fisheries, and theoretical ecology. She is a member of the NSERC's canadian capture fisheries research network and also involved in the North Atlantic Marine Mammal Commission and the International Whaling Commission.

Steve Leach is a Senior Biologist with Normandeau Associates in Westmoreland, NH where he has worked since 2006, specializing in diadromous fish behavior and passage at hydroelectric dams. Steve grew up in Maryland, earned a B.S. in biology from Elon College, North Carolina in 1990, and an M.S. in oceanography and coastal science from Louisiana State University in 1993. Steve's work experiences range from academic to state resource agency to environmental consulting, and include: investigations of larval fish transport on the Gulf Coast of Louisiana while working for LSU's Coastal Fisheries Institute; early life survival and production of anadromous species and Chesapeake Bay trophic dynamics while working for the University of Maryland's Chesapeake Biological Laboratory; diadromous fish restoration and endangered shortnose sturgeon research while working for the South Carolina Department of Natural Resources; and FERC hydroelectric project relicensing and license compliance issues in many U.S. rivers as an employee of Normandeau Associates.

## Vermont Swims toward Improved Aquatic Organism Passage

Over the past six years, the Vermont Departments of Fish and Wildlife (VDFW) and Environmental Conservation (VDEC) have made great progress in improving aquatic organism passage (AOP) at road/ stream crossings in Vermont. These efforts include:

- Hosting technical AOP design workshops for state and consulting engineers, environmental contractors, transportation planners, biologists and regulators.
- Developing and implementing technical design guidelines for AOP at road/stream crossings.
- Developing and implementing protocols to assess AOP and geomorphic compatibility at culverts throughout Vermont.
- Developing screening tools to identify potential AOP enhancement projects from culvert assessment information.

- Producing workshops for local state and municipal road crews on the effect of road/stream crossings on AOP and geomorphic compatibility.
- Producing and distributing the "Vermont Stream Crossing Handbook" which provides a less technical overview of ecological and geomorphic issues associated with road/stream crossings for use by town officials, local and regional planning commissions, conservation organizations and developers.
- Implementing AOP enhancements at road/stream crossings in cooperation with local watershed and angling groups, conservation organizations, US Fish and Wildlife Service and US Forest Service.
